I, the undersigned, wish to store my personal golf cart in rented space at Chamberlain Country Club (the "Club") and/or rent a cart seasonally from the Club's fleet for use on its premises. In consideration, I agree as follows:

I understand golf cart use and storage involve risks of damage, theft, injury, or death. I assume all such risks voluntarily.

**Release:** I release the Club, its owners, officers, employees, agents, and assigns (the "Released Parties") from all claims, liabilities, damages, or losses (including attorneys' fees) related to:

1. Damage, loss, or theft to my personal cart while stored or used on premises.
2. Any incident, accident, injury, or damage involving my personal cart on the course or premises.
3. For renters: Any incident, accident, injury, or damage while using a Club cart.
4. Damage to a rented Club cart (I agree to pay for repairs/replacement).

This release covers negligence (except willful misconduct) and applies regardless of cause.

**Responsibility:** I am solely responsible for safe operation, maintenance, and security of any cart (owned or rented). I am 18+ and hold a valid driver's license if required. I will follow Club rules and laws.

**Indemnification:** I will indemnify and hold harmless the Released Parties from third-party claims arising from my cart use or storage.

**Misc:** If any provision is invalid, others remain enforceable. Governed by South Dakota law.

I have read, understand, and voluntarily sign this, waiving legal rights.
